1. **Call to Order:** By Chair Teitgen at 6:30 p.m.
2. **Roll Call:** F. Teitgen, R. Schmidt, V. Auck, D. Long, S. Smith, R. Lombardo, K. Schulenburg & M. Schmidt.

3. **Approval of Agenda.** Approved as presented.
4. **Rules of Conduct.** Were read by Chair Teitgen.
5. **Approval of last meeting minutes.** Approved as presented.
6. **Constable's Report.** For the first time ever 3 calls were received with snowmobile related complaints, groomer blocking driveways with snow mounds, trail too close to residents bedroom window and snowmobilers crossing private driveways. Loose dog complaint on Wildcat Rd.
7. **Consider outdoor entertainment regulations/guidelines as modified per town board input.** Schmidt/Long motion to approve the guidelines dated 1-14-2011, MC.
8. **Public input and consideration of possible ordinance permitting snowmobile trails access on town roads.** S. Scherer of Arlington Prairie Drifters Snowmobile Club, feels the draft ordinance is a good one, would recommend tweaking the verbiage regarding preferred primary access roads. D. O'Connor concerns with current trail on Hooker Rd. being too close to residences. Mr. Hineline feels driveways are being ruined, would allow snowmobilers to cross over a hill on his property off CTH CS rather than use Hooker Rd. T. Leckwee suggests using the most direct route to access trails. P. Nadowski says Club should go to County to have CTH CS and CTH J designated as snowmobile route, then the edge of roadway travel would be allowed. Language will be added to the draft Ordinance for those on Tipperary Rd. to utilize the shortest routes to the closest boat landings for lake and/or river access and too clarify speed limit issue, will continue discussion at the next meeting.
9. **Consider possible ordinance permitting Low Speed Neighborhood Vehicles.** Teitgen/Smith motion to send draft Ordinance back to the Town's Attorney for review prior to submitting to the Town Board for approval, MC.
10. **Consideration of possible Waste Treatment Facility (Landfill) Ordinance.** Teitgen/Auck motion to forward onto the Town Board for approval pending some re-working on section D-4, MC.
11. **Discussion of municipal court.** Constable will contact Clerk of Municipal Courts and ask her to attend a meeting to explain/discuss the pros and cons of the system and how it all will work.
12. **Future agenda items. (no discussion permitted.)** Continuation of snowmobile ordinance, municipal court info & draft a letter to Representative Ripp regarding wind turbine siting.
