A public hearing will be held before the Town Board of the Town of Dekorra on March 12, 2013, at 6:30 p.m., concerning a Resolution providing for the discontinuance of a portion of White Oak Court in the Town of Dekorra described as follows:

Part of White Oak Court, Block 28, Wisconsin Beach Gardens, located in Government Lot 3, Section 6, Town 11 North, Range 9 East, Town of Dekorra, Columbia County, Wisconsin, more particularly described as follows:


Beginning at the northeast or most northerly corner of Lot 3, Block 28; thence S 62° 38' 12" W 399.68 feet along the northwesterly line of Lots 3 through 18 to the northwest or most westerly corner of Lot 18; thence N 27° 21' 48" W 20.00 feet to the southwest or most southerly corner of Lot 19;

Thence N 62° 38' 12" E 399.68 feet along the southeasterly line of Lots 19 through 34 to the southeast or most easterly corner of Lot 34; thence S 27° 21' 48" E 20.00 feet to the point of beginning.

Notice is further given that a correct drawing of said street is attached hereto. Proceedings after the introduction of the said Resolution will be had according to the provisions of Section 66.1003 of the Wisconsin Statutes.




