Subject: Town of Dekorra Tourist Rooming Houses Density Limits

- 1. Brief Public Comments.** B. Lubing had concerns with noise, camp fire smoke, fireworks, density, trash, sheriff calls and feels TRH should only be allowed in Commercial Zoning.
- 2. Discussion/possible action regarding establishment of density limits on Tourist Rooming Houses in the Town of Dekorra.** Discussion included but was not limited to spacing of 800-1000 feet between each TRH, limiting each owner a set number of permits, limiting number of times per year home is rented out, reviews on an annual basis.
- 3. Discussion/possible action on enforcement of and action in the event of violations of Tourist Rooming House conditions.** Complaints should be backed by evidence, limit of 3 complaints in any six month period which will then involve a public hearing for possible revocation of permit, Clerk will create a complaint form and use for each TRH.
