**RESOLUTION OF THE TOWN MEETING OF THE TOWN OF DEKORRA  
AUTHORIZING PURCHASE OF LAND**

**WHEREAS**, one of the topics of the special Town Meeting was to approve the purchase of property that is part of parcel 11010-54 to add to the property upon which the Dekorra Town Hall is situated (parcel 11010-54.01) both in the Town of Dekorra, Columbia County, WI; and

**WHEREAS**, the Town Board requests authorization to complete such purchase by way of an exchange of approximately equal amounts of property between parcels 11010-54 and 11010-54.01 for the purpose of reconfiguring the Town Hall property to better accommodate additional on-site parking for the Town Hall, the preliminary and approximate depiction of such exchange being shown on Exhibit A attached hereto:

**NOW, THEREFORE, BE IT RESOLVED**, that we, the Town Electors of the Town of Dekorra, being duly assembled at a special Town Meeting on \_\_\_\_\_, 2022, do hereby authorize, by a majority vote of the eligible electors, the Town Board of the Town of Dekorra to exercise the right to purchase at a cost of the exchange of substantially equal amounts of property between parcels 11010-54 and 11010-54.01 with the final amount and configuration of land to be determined by the Town Board, for town public purposes, pursuant to Wis. Stats. 60.10(2)(e) with the costs of surveying, closing and recording to be paid by the Town of Dekorra
